ORDER

This Criminal Revision Case has been filed as against the Judgment dated 06.06.2024 passed in C.A.No.69 of 2023, on the file of the learned court of Sessions Division of the Nilgiris District, Udthagamandalam, confirming the order of conviction passed by the Judicial Magistrate Court, Udthagamandalam in S.T.C.No.917 of 2018 thereby convicting the petitioner for the offence punishable under Section 138 of Negotiable Instruments Act.
