Counsel says in view of developments post filing of petition, nothing will survive and the court may dispose of the petition.

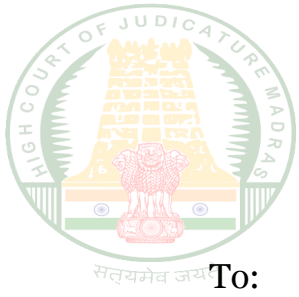
