ORDER

This Sua Motu Case is dealt with in an extraordinary manner by the Dedicated Bench, pursuant to Sua Motu.W.P.(CrI.) No.618 of 2025.

2. This Case in Cr.No.87 of 2021 is registered for alleged offences under Sections 294(b), 324, 506(ii) of Indian Penal Code. It is submitted that there is a connected counter case in C.C.No.154 of 2022. In both these cases, the parties have compromised the issue and have no objection for disposing this case on compromise. Due to the unique manner in which this dedicated bench conducts hybrid hearings, the filing of written affidavits or terms of

compromise is dispensed with. Considering the factual matrix, the context in which the conflict arose, the background of the parties, and their present position, this is an appropriate case for the exercise of jurisdiction under Section 482 of the Code of Criminal Procedure as per ***Gian Singh -vs- State of Punjab & another, (2012 10 SCC 303)***.

3. Accordingly, both the cases in CC.No.21 of 2025 and C.C.No.154 of 2022 on the file of Judicial Magistrate Court, Dharapuram, Dharapuram Taluk, Tiruppur are quashed and this Sua Motu Transfer Case is disposed of.
