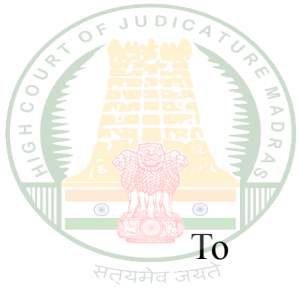
5. On a perusal of the records, this Court finds that there is a specific allegation against the petitioner and there are prima facie materials to conduct investigation.
