Without expressing any opinion on the merits of the writ petition, the 2nd respondent is directed to consider the representation of the petitioner dated 08.07.2025 and after conducting an enquiry by issuing notice to the petitioner and the counter parties, if any, and affording them a personal opportunity of hearing, to pass appropriate orders on merits and in
