This Writ Petition has been filed seeking a direction to forbear the first respondent from opening the tender documents in respect of tender notice No.24/2025-2026/SDO dated 17.09.2025 of the first respondent herein in respect of the works of upgradation of Panchayat Union/Panchayat Roads to other Districts (SLM 6) (a) upgradation of Mulaiyettankadu to Vettraperumal Kovil via Poojakadu Kattiveerankadu Surapuliyankadu Km 0/0-2/900 (b) upgradation of Marakottai road to Thailagoundanur road Km 0/0-2/200 (c) upgradation of Pandhakaranur to Kangani patti road Km 0/0-2/870; Upgradation of Panchayat Union/Panchayat Roads to other Districts (SLM 7) (a) upgradation of Nagichettipatty to Bhagavatiyamman koil road Km 0/0-3/600 (b) upgradation of Vaiguntham Kolikalnatham Road to (via) Perumal Kovil Uthupalayam road Km 0/0-2/330 (c) upgradation to Mallankadu Road Km 0/0-2/0. The learned counsel for the petitioner submitted that the petitioner is a registered contractor with the respondents and intended to participate in the e-tender and to submit bids by 11.00 hours on 14.10.2025, for which he had to produce Work Site Inspection and Plant & Machineries Certificates. He further submitted that the respondents refused to receive the petitioner's application for issuance of the aforesaid certificates. Hence, the present Writ Petition.

4. The learned Additional Advocate General fairly submits that the petitioner will be issued separate certificates on or before 10.10.2025.

5. Recording the submission made by the learned Additional Advocate General, the present Writ Petition stands disposed of.
