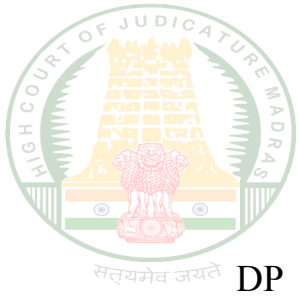

3. The learned counsel for the petitioner submitted that the petitioner is a registered contractor with the respondents and intended to participate in the e-tender and to submit bids by 11.00 hours on 14.10.2025, for which he had to produce Work Site Inspection and Plant & Machineries Certificates. He further submitted that the respondents refused to receive the petitioner's application for issuance of the aforesaid certificates. Hence, the present Writ Petition.
