After the petition was heard for some time, Ms.Jhothivani sought leave to withdraw the petition.

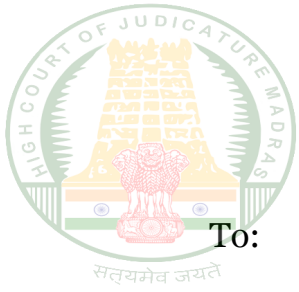
Petition is dismissed as withdrawn. There shall be no order as to costs.
