ORDER

Apprehending arrest in connection with Crime No.1041 of 2024 registered for the offences punishable under Sections 126, 296(b), 324(2), 309, and 351 of Bharatiya Nyaya Sanhita, 2023 (BNS), the present petition has been filed seeking anticipatory bail.



2. Pleading innocence on the part of the petitioner, false implication in the case,

learned counsel for the petitioner seeks indulgence of this Court. He further submitted that the petitioner has no way connection with the charges levelled by the prosecution. However, the petitioner is ready to abide by any stringent condition that may be imposed by this Court.

3. The case of the prosecution as putforth by the learned Government Advocate (Crl. Side) appearing for the respondent Police, opposing for grant of anticipatory bail, is that the petitioner, who is a notorious rowdy of the area, demanded rowdy mamool from the de-facto complainant, a fruit vendor and intimidate him and forcibly took away a sum of Rs.1,200/- from him at knife point. He further submits that there are no previous cases pending against him.

4. Having heard the learned counsel for the petitioner and the learned Government Advocate (Crl. Side) for the respondent Police and perused the materials available on record, this Court is inclined to grant anticipatory bail to the petitioner with certain conditions and accordingly the petitioner is ordered to

fifteen days from the date of receipt of a copy of this order, before the *learned*

Judicial Magistrate, Ambattur, Chennai, on condition that the petitioner shall

execute a bond for a sum of Rs.10,000/- (Rupees Ten Thousand only), with two

sureties each for a like sum to the satisfaction of the respondent Police or the

Police officer who intends to arrest or to the satisfaction of the said Magistrate,

on further condition that:

[a] if the petitioner fails to surrender before the said Magistrate within a period of fifteen days, this Order shall stand automatically cancelled;

[b] the petitioner shall report before the respondent Police daily at 6.30 P.M., until further orders;

[c] the petitioner shall not tamper with evidence or witness either during the investigation or during the trial;

[d] the petitioner shall not abscond either during the investigation or during the trial;

[e] On breach of any of the aforesaid conditions, the learned Magistrate/Trial Court is entitled to take appropriate action against the petitioner in accordance with law as if the conditions have been imposed and the petitioner was released on bail by the learned Magistrate/Trial Court himself as laid down by the Hon'ble

Supreme Court in P.K.Shaji vs. State of Kerala [(2005)AIR SCW

[f] If the petitioner thereafter absconds, a fresh FIR can be registered under
Section 269 of BNS.
