under the 3% reservation for differently abled persons as provided in the TANGEDCO proceedings No.119, dated 29.11.2012.

In view of the above, the first respondent is directed to consider the appeal submitted by the petitioner dated 22.08.2025 and 23.09.2025 and dispose of the same on merits and in accordance with law, after affording an opportunity of hearing to the petitioner, within a period of twelve weeks from the date of receipt of a copy of this order.

5. With the above direction, this Writ Petition stands disposed of. Consequently, connected miscellaneous petitions are closed. There shall be no order as to costs.
