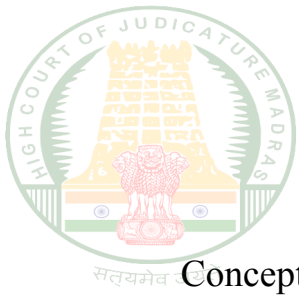

ORDER

The petitioner, who was arrested and remanded to judicial custody
on 09.09.2025, for the offence punishable under Sections 88, 66 of the
Bharatiya Nyaya Sanhita, 2023 and Sections 6(a), 6(b) and 23 of the Pre-

Conception and Pre-Natal Diagnostic Techniques (Prohibition of Sex Selection) Act, 1994, in Crime No.116 of 2025, registered on the file of the respondent, seeks bail.

2. The case of the prosecution is that the petitioner, along with other accused, conducted a 'Prenatal Diagnostic Test' and found that the foetus in the womb was female. It is further alleged that the petitioner and others aborted the foetus by administering certain medicines after collecting a huge amount. Hence, the complaint.

3. Learned counsel appearing for the petitioner submitted that the petitioner is an innocent person and has been falsely implicated in this case. She further submitted that one of the co-accused has already been granted bail by this Court in Crl.O.P.No.27103 of 2025 dated 03.10.2025, and the petitioner has been in custody since 09.09.2025. Hence, she prayed for grant of bail to the petitioner.

4. Learned Government Advocate (Criminal Side) appearing for the respondent police opposed the grant of bail, reiterating the prosecution

case and submitted that there are totally five accused in this case, and the petitioner is ranked as A5. He further submitted that the petitioner has a previous case of similar nature.

5. Heard both sides and perused the materials available on record.

6. Considering the nature of the allegations, the fact that the petitioner is a woman, and taking into account the period of incarceration, this Court is inclined to grant bail to the petitioner with certain conditions:

7. Accordingly, the petitioner is ordered to be released on bail on his executing a bond for a sum of **Rs.20,000/- (Rupees Twenty Thousand only)** with **two sureties**, each for a like sum to the satisfaction of the learned **Judicial Magistrate No.II, Tirupathur**, and on further conditions that:

[a] the sureties shall affix their photographs and Left Thumb Impression in the Application for Surety ship [Judicial Form No.46 annexed to 'The Criminal Rules of Practice, 2019']. The learned Magistrate shall obtain a copy of any one of the identity proofs to ensure their identity;

[b] the petitioner shall report before the respondent police for a period of two weeks, and thereafter as and when required for interrogation;

[c] the petitioner shall make himself available for interrogation by a Police Officer as and when required;

[d] the petitioner shall not directly or indirectly cause any threat to the de facto complainant and witnesses;

[e] the petitioner to give an undertaking that if required for being identified by witnesses during investigation or for police custody beyond the first fifteen days, he shall comply to the directions as may be given by the Court in this regard;

[f] On breach of any of the aforementioned conditions, the learned Magistrate/Trial Court is entitled to pass appropriate orders against the petitioner in accordance with law as if the aforementioned conditions have been imposed and the petitioner released on bail by the learned Magistrate/Trial Court himself as laid down by the Hon'ble Supreme Court in **P.K.Shaji vs. State of Kerala [(2005)13 SCC 283]**;

[g] If the accused thereafter absconds, a fresh FIR can be registered under Section 269 of B.N.S.
