This Writ Petition has been filed seeking a direction to the third respondent to issue the Work Site Inspection and working condition of the plants and machinery certificate to the petitioner for the tender notification in Tender Notice No.23/2025-2026/HDO dated 21.08.2025 issued by the second respondent forthwith.

The learned counsel for the petitioner submitted that the petitioner is a registered contractor with the respondents and intended to participate in the e-tender and to submit technical bids by 13.15 hours on 09.10.2025, for which he had to produce Work Site Inspection and Plant & Machineries Certificates. He further submitted that though the petitioner has made application for the aforesaid certificates, the same were not issued to the petitioner. Hence, the present Writ Petition.
