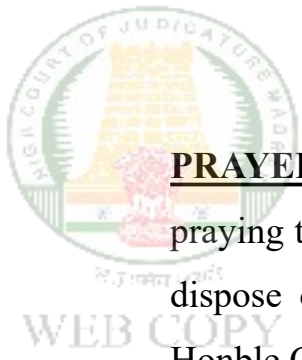

ORDER

The Civil Revision Petition is filed seeking a direction to trial court to dispose of the suit in O.S.No.63 of 2024 within a time frame fixed by this court.

2. The petitioner herein filed a suit seeking declaration and recovery of possession. The suit was filed during May 2024.

3. A perusal of the remarks submitted by the learned Trial Judge would indicate that the first defendant filed his written statement on 10-02-2025 and the same was adopted by defendants 2 to 9. The defendants 10 and 11 were set ex-parte and the suit was posted for framing of issues.
