2. **This Case in Crime No.15 of 2016 dated 10.01.2016 is registered for alleged offences under Sections 406 and 420 of Indian Penal Code.** The defacto complainant whereabouts also not known and the defacto complainant does not want to pursue the matter any further. Considering the factual matrix, context of the case, the antecedents of the accused, the reason for absence from his usual place, and the submission that, despite best efforts, the summons / warrant could not be served / executed, it is evident that even if the accused is brought to face trial, it would impinge upon his right to a speedy trial. Due to the passage of time, a meaningful trial is unlikely, and no useful purpose would be served.

3. Accordingly, the proceedings in **C.C.No.307 of 2022 on the file of District Munsif cum Judicial Magistrate, Denkanikottai Taluk, Krishnagiri** is quashed and this Sua Motu Transfer Case is disposed of.
