**ORDER**

7. Registry is directed to list the above Second Appeal after numbering the same, if they are otherwise in order, on 28.04.2025.

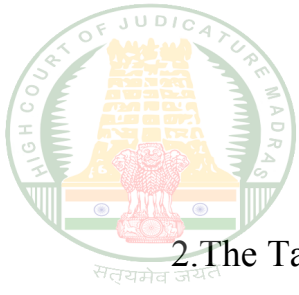
