3. Learned counsel appearing for the petitioner submits that the respondent is threatening the petitioner that, another CSR is pending against him. He also submits that the petitioner had furnished sureties and also ready to appear before the Judicial Magistrate Court - II at Alandur, therefore, he prayed to modify the condition of appearing before the respondent police.

Considering the submissions of both sides and the nature of offence, the condition in para 6(b), imposed on the petitioner in Crl.O.P.No.30004 of 2024, dated 02.12.2024, is **modified** to the effect that **the petitioner shall report before the learned Judicial Magistrate -II, Alandur on all working days at 10:30 a.m., until further orders.**

5. Accordingly, this criminal miscellaneous petition is ordered.
