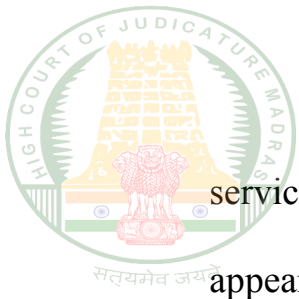

2.Heard the learned counsel for the petitioner Ms.V.Nalini. Despite



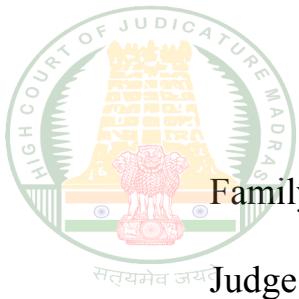

The petitioner has expressed her genuine inconvenience for travelling all the way to Nagercoil and has come forward seeking transfer of the said proceedings on the file of the Family Court, Chennai and has made out justifiable grounds seeking transfer of HMOP No.387 of 2024 from the file of Family Court, Kanyakumari at Nagercoil to the file of the Family Court, Chennai.

4. I have also gone through the averments set out in the affidavit filed in support of the petition and I am satisfied with the reasons assigned in the affidavit and the petitioner has made out a prima facie case for seeking transfer as prayed for.
