ORDER

Pursuant to the order passed by this Court on 02.12.2025, today the case is listed under the caption 'For reporting compliance'.

2.The petitioner was granted suspension of sentence by this Court with certain conditions and one of the conditions was that the petitioner to deposit a sum of Rs.11,00,000/- in two installments, i.e., first instalment of Rs.5,00,000/- within a period of two weeks from the date of receipt of a copy of the order. The second instalment of Rs.6,00,000/- to be deposited within a period of two weeks thereafter.



3. Today, the learned counsel for petitioner produced receipt dated 09.12.2025 for a sum of Rs.5,00,000/- and receipt dated 24.12.2025 for a sum of Rs.6,00,000/- and submitted that the petitioner has complied with the directions of this Court. 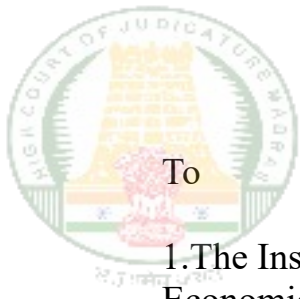
