ORDER

2. The petitioner herein/plaintiff filed the above said suit seeking permanent injunction and mandatory injunction. A perusal of the adjudication sheets filed in the typed set of papers would indicate that the pleadings of the parties were already completed and the suit was posted for trial in the special list as early as on 21.12.2023.
