ORDER

This writ petition has been filed seeking issuance of a writ of mandamus directing the respondents to deal with the petitioners' representation dated 30.06.2025 wherein the petitioners have sought sub-division of the property and for issuance of patta in respect of the subject property.

2. Heard Mr.Balan Haridas, learned counsel for petitioners, Mr.P.Ganesan, learned Government Advocate appearing for respondents 1 to 3 and Mr.C.Selvaraj, learned Additional Government Pleader appearing for fourth respondent.

3. The case of the petitioners is that they are owners of a large extent of land and the Indian Railways acquired a large extent of land. With respect to the unacquired balance extent of land, the petitioners applied for issuance of sub-division patta. The applications submitted by the petitioner on 21.11.2024 and thereafter on 24.02.2025 did not evoke any response. It is under these circumstances, the present writ petition has
