4. In the light of the above development, there shall be a direction to the 2nd respondent to deal with the representation made by the petitioner on 02.07.2025 and do the needful, within a period of twelve weeks from the date of receipt of copy of this order.

5. This writ petition is disposed of with the above directions. No Costs.
