ORDER

This writ petition has been filed for declaration declaring the action of the respondents in not paying the commuted value of pension and encashment of unearned leave on private affairs to the petitioner consequent on his retirement on 30.06.2020 as illegal, arbitrary and contrary to law and consequently to direct the respondents to pay commuted value of pension and encashment of unearned leave on private affairs to the petitioner within the time frame stipulated by this court along with interest at the rate of 10 % per annum from the date when the terminal benefits became due till the date of actual disbursement
