PRAYER

Writ Petition is filed under Article 226 of the Constitution of India seeking Mandamus for a direction to the Respondent to pay the Petitioner interest for the belated payment of his terminal benefits, namely P.F. Gratuity, surrender leave salary and Earned Leave Salary; to pay him a sum of Rs.18500/- towards the STERBS Fund and to pay him a sum of Rs.130974/- towards difference in Gratuity, together with interest at the rate of 18% for all above benefits, within a specified time frame as may be timed by this Court, Award costs.

ORDER

This Writ Petition has been filed for direction directing the respondents to pay appropriate interest to the petitioner for the delayed sanction and disbursement of retirement benefits.

2. Heard the learned counsel appearing on either side and perused the materials available on record.

3. In identical issues, this Court has passed various orders, justifying the payment of interest to the aggrieved pensioners and in the order dated 13.12.2019 in W.P.(MD) No.26481 of 2019, the following order came to be passed :-

“5. I am not in agreement with the said representation made. There was already a duty cast on the respondent Corporation to pay the terminal benefits on the date of



5. In the light of the above findings, there shall be a direction to the respondent herein to pay the interest on the belated payment of the terminal benefits to the petitioner at the rate of 6% per annum, commencing from the



date of the retirement, till the date of actual disbursement, within a period of eight weeks from the date of receipt of a copy of this order.

6. With the above direction, this Writ Petition is disposed of. No costs.
