ORDER

The petitioner, who was arrested and remanded to judicial custody on 13.09.2025 for the offences punishable under Sections 8(c) and 20(b)(ii)(B) of NDPS Act in Crime No.306 of 2025, registered on the file respondent police, seeks bail.

2. The case of the prosecution is that on 13.09.2025, based on a secret information, the respondent police went to the spot and found that the petitioner along with other accused were in joint possession of 5 kilograms of ganja. Hence, this case.

3. The learned counsel appearing for the petitioner submitted that the petitioner is aged about 18 years, she has been falsely implicated in this case and in judicial custody since 13.09.2025; and that the petitioner is ready to abide by any conditions that may be imposed by this Court and sought for bail to the petitioner.

4. The learned Government Advocate (Crl. Side) appearing for the respondent while opposing the bail to the petitioner reiterated the



prosecution case and stated that there are totally nine accused involved in this case and the petitioner is arrayed as A4; that the petitioner has no previous antecedents; and that the investigation of the case is pending.

5. Considering the facts of the case, the quantity of contraband involved, the petitioner being a lady and she has no previous antecedents and considering the period of incarceration undergone by the petitioner, this Court is inclined to grant bail to the petitioner with certain conditions.

6. Accordingly, the petitioner is ordered to be released on bail on his executing a bond for a sum of **Rs.20,000/- (Rupees Twenty Thousand only)** with **two sureties each**, for a like sum to the satisfaction of the **learned District Munsif Cum Judicial Magistrate Court at Annur** and on further conditions that:

[a] the sureties shall affix their photographs and Left Thumb Impression in the Application for Surety ship [Judicial Form No.46 annexed to 'The Criminal Rules of Practice, 2019']. The learned Magistrate shall obtain a copy of any one of the identity proofs to ensure their identity;

[b] the petitioner shall report before the respondent police daily at 10:30 a.m., for a period of four weeks and thereafter, as and when required for interrogation;

[c] On breach of any of the aforementioned conditions, the learned Magistrate/Trial Court is entitled to pass appropriate orders against the petitioner in accordance with law as if the aforementioned conditions have been imposed and the petitioner released on bail by the learned Magistrate/Trial Court himself as laid down by the Hon'ble Supreme Court in **P.K.Shaji vs. State of Kerala [(2005)13 SCC 283]**;

[d] If the accused thereafter absconds, a fresh FIR can be registered under Section 269 of B.N.S.
