PRAYER: Petition filed under Article 226 of the Constitution of India seeking issuance of a writ of mandamus directing respondents 1 to 6 to forthwith cancel all Trade Licences, approvals and permissions granted in favour of respondents 7 to 9 and to seal the premises at Plot Nos.1/6 and 1/7, Bazaar Road, Mogappair East, Zone 7, Ward 93, Chennai-600 037, including in particular the ground floor parking area illegally converted into a Fast Food outlet, Juice Stall, store room, kitchen and toilets, and the other portions misused as a Lodge and Restaurant, which are being operated without lawful authority without a valid rental agreement and without payment of rent to the petitioner.
