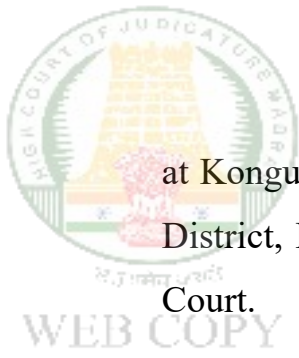

2.Compliance of the order dated 30.10.2025, as submitted by the learned Advocate Commissioner is recorded.

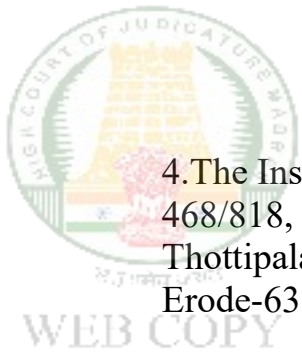
