ORDER

The petitioner, who was arrested and remanded to judicial custody on
20.09.2025 for the alleged offence under Section 376, 506(i), and 34 Of IPC
in Crime No.27 of 2025 on the file of the respondent police, seeks bail.



2. The case of the prosecution is that the petitioner herein developed relationship with the victim aged about 32 years and made a promise to marry her, had sexual intercourse with the victim and subsequently, refused to marry her. Hence, the case.

3. The learned counsel appearing for the petitioner submitted that the petitioner has not promised to marry her. However, only a consensual relationship for a longer period and due to difference of opinion, the marriage had not taken place and it is not a case of cheating. He further submitted that the petitioner is in judicial custody from 20.09.2025. He further submitted that the petitioner is ready to abide by any conditions that may be imposed by the this Court. Hence, he prays to grant bail to the petitioner.

4. The learned Government Advocate (Criminal Side) appearing for the respondent police reiterated the prosecution case and submitted there are three accused involved in this case and other two accused are relatives of this petitioner and this petitioner made a promise to marry her and later refused to marry her. He further submitted that investigation is pending. Hence, he opposed to grant bail to the petitioner.

5. Heard both sides and perused the materials available on record.



6. Considering the facts and circumstances of the case, the submissions made by both counsel, the period of incarceration and also the content in the FIR reveals various facts including the long standing relationships between the victim and the petitioner, I am inclined to grant bail to the petitioner with certain conditions.

7. Accordingly, the petitioner is ordered to be released on bail on his executing a bond for a sum of **Rs.25,000/- (Rupees Twenty Five Thousand only)** with **two sureties**, for a like sum to the satisfaction of the learned **Judicial Magistrate, Additional Mahila Court, Coimbatore** and on further conditions that:

[a] the sureties shall affix their photographs and Left Thumb Impression in the Application for Surety ship [Judicial Form No.46 annexed to 'The Criminal Rules of Practice, 2019']. The learned Magistrate shall obtain a copy of any one of the identity proofs to ensure their identity;

[b] **the petitioner shall report the respondent police daily at 10.30 a.m., for a period of two weeks and thereafter as and when and required for interrogation;**

[c] On breach of any of the aforementioned conditions, the learned Magistrate/Trial Court is entitled to pass appropriate orders against the petitioner in accordance with law as if the aforementioned conditions have been imposed and the petitioner released on bail by the learned Magistrate/Trial Court himself as laid down by the Hon'ble Supreme Court in **P.K.Shaji vs. State of Kerala [(2005)13 SCC 283]**;

[d] If the accused thereafter absconds, a fresh FIR can be registered under Section 269 of B.N.S.
