2.After hearing both sides, this Court modifies the conditions imposed against the petitioner in CrI.O.P.No.5864 of 2025, dated 22.08.2025, wherein, the relevant Paragraph No.4 which reads as follows:-

**“8(c). that the petitioners shall report before the respondent police monthly twice i.e., on every first and last working day of English Calender month at 10.30 am for a period of four months from today.”**

3. The rest of the conditions in CrI.O.P.No.5864 of 2025, dated 22.08.2025, shall remains unaltered.
