ORDER

The petitioner, who was arrested and remanded to judicial custody on
04.10.2025 for the alleged offence under Sections 191(2), 191(3), 296(b),
115(2), 118(1), 310(1), 351(3), 140(3) of BNS, 2023 in Crime No.141 of
2025 on the file of the respondent police, seeks bail.



2. The case of the prosecution is that due to previous enmity, the petitioner joining hands with other accused formed an unlawful assembly and attacked the defacto complainant with deadly weapons and caused grievous injuries to him. Further, they have attempted to abduct him. Hence, complaint was lodged against the petitioner.

3. The learned counsel appearing for the petitioner submitted that the petitioner has been falsely implicated in this case and he is in judicial custody from 04.10.2025. He further submitted that the petitioner is ready to abide by any stringent conditions that may be imposed by this Court. Hence, he prayed for grant of bail to the petitioner.

4. The learned Government Advocate (Criminal Side) appearing for the respondent police reiterated the prosecution case and reported that the petitioner is having bad antecedents and he is having three previous cases. Hence, he opposed to grant bail to the petitioner.

5. Heard both sides and perused the materials available on record.

6. Considering the nature of allegations and the fact that the petitioner is having three previous cases, I am not inclined to grant bail to this petitioner.

7. Accordingly, this Criminal Original Petition is dismissed.
