ORDER

The petitioner, who was arrested and remanded to judicial custody on 27.09.2025 for the offences punishable under Section 309(4) and 311 of BNS in Crime No.228 of 2025, registered on the file respondent police, seeks bail.

2. The case of the prosecution is that on 09.09.2025 at about 10:00 a.m., the petitioner waylaid the defacto complainant near Old Vasur Palar river bed and robbed a sum of Rs.1,000/- from him at knife point. Hence, this case.

3. The learned counsel appearing for the petitioner submitted that since the petitioner is having previous antecedents, he has been falsely implicated in this case by the respondent police for the statistical purpose and he is in judicial custody since 27.09.2025; and that the petitioner is ready to abide by any conditions that may be imposed by this Court and sought for bail to the petitioner.

4. The learned Government Advocate (Crl. Side) appearing for



the respondent while opposing the bail to the petitioner reiterated the prosecution case and stated that the petitioner has four previous cases; and that the investigation of this case is pending.

5. Considering the facts of the case and submissions made on both sides, nature of allegation and the period of incarceration undergone by the petitioner, this Court is inclined to grant bail to the petitioner with certain conditions.

6. Accordingly, the petitioner is ordered to be released on bail on his executing a bond for a sum of **Rs.20,000/- (Rupees Twenty Thousand only)** with **two sureties each**, for a like sum to the satisfaction of the **learned Judicial Magistrate, Katpadi, Vellore District** and on further conditions that:

[a] the sureties shall affix their photographs and Left Thumb Impression in the Application for Surety ship [Judicial Form No.46 annexed to 'The Criminal Rules of Practice, 2019']. The learned Magistrate shall obtain a copy of any one of the identity proofs to ensure their identity;

[b] the petitioner shall report before the learned Judicial Magistrate, Katpadi, Vellore District daily at 10:30 a.m., for a period of three weeks and thereafter, as and when required for interrogation by the respondent police;

[c] On breach of any of the aforementioned conditions, the learned Magistrate/Trial Court is entitled to pass appropriate orders against the petitioner in accordance with law as if the aforementioned conditions have been imposed and the petitioner released on bail by the learned Magistrate/Trial Court himself as laid down by the Hon'ble Supreme Court in **P.K.Shaji vs. State of Kerala [(2005)13 SCC 283]**;

[d] If the accused thereafter absconds, a fresh FIR can be registered under Section 269 of B.N.S.
