Writ Petition filed under Article 226 of the Constitution of India seeking issuance of a Writ of Mandamus directing the respondents 1 and 2 to consider the petitioner's representation dated 08.07.2025 and thereby direct the respondents 1 and 2 to measure the property with the help of third respondent erect the mile stones and issue a separate patta in the name of the petitioner in Survey No. 258/2H to an extent of 0.06 3/4 cents and Survey No.209/B18 to an extent of 1804 sq.ft situated at Sikkathoranapettam Revenue Village, Palacode Taluk, Dharmapuri district in the light of first respondent letter dated 16.09.2025.

3. The petitioner is claiming right and title over the subject property by virtue of a partition deed dated 09.05.2025 registered as document No.1350 of 2025. The petitioner submitted an application seeking survey of the property and issuance of separate patta in his name. Since the same was not acted upon, the present writ petition has been filed.

Taking into consideration the facts and circumstances of the case and the materials placed before this Court, there shall be a direction to respondents 1 and 2 to act upon the petitioner's representation dated 08.07.2025 and deal with the same on its own merits and in accordance after affording opportunity to all interested parties concerned. The entire process shall be completed within a period of eight (8) weeks from the date of receipt of a copy of this order.
