ORDER

This Writ Petition has been filed seeking a direction 1st and 2nd Respondents herein to consider the petitioner's representation dated 26.09.2025 seeking permission to fix “Change Over Switch” for the Borewell belonging to the petitioner situated in S.F.No.223/3B, Nambiapalayam Village, Avinashi Taluk within the time that may be stipulated by this Court.

2. Mr.L.Jaivenkatesh, learned Standing Counsel takes notice on behalf of the respondents.

3. It is the case of the petitioner that he had submitted a representation dated 26.09.2025 to the respondents seeking permission to fix “Change Over Switch” for the Borewell situated in his property. However, the same has not been considered so far. Hence, the petitioner has come up with the present Writ Petition.

4. Though very many grounds have been raised, learned counsel for the petitioner submits that it would suffice, if this Court issues a direction to the respondents to consider the petitioner's representation dated 26.09.2025 and pass orders on the same within the time that may be stipulated by this Court.

5. Learned Standing Counsel appearing for the respondents submitted that the petitioner's representation dated 26.09.2025 will be considered and appropriate orders will be passed.

6. In view of the limited relief sought for in this Writ Petition, this Court without expressing any opinion on the merits of the case, directs the respondents herein to consider the petitioner's representation dated 26.09.2025 and pass appropriate orders on the same in accordance with law within a period of six (6) weeks from the date of receipt of a copy of this order, after affording an opportunity of hearing to the petitioner and any other interested parties.

7. This Writ Petition stands disposed of with the aforesaid direction. There shall be no order as to costs.
