**ORDER**

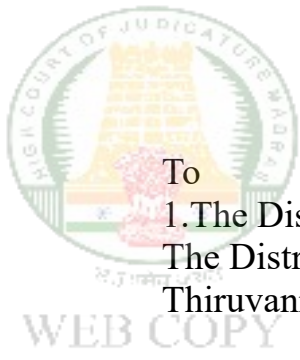
