PRAYER: Criminal Original Petitions filed under Section 528 of B.N.S.S. to set aside the adjudication order dated 10.09.2025 in Crl.407 of 2025 passed by the II Additional Court, Chennai and extend the time for depositing 20% of the cheque amount as directed while suspending the sentence in Crl.M.P.No.1 of 2025 in Crl.A.No.407 of 2025 pending before the II Additional Sessions Court, Chennai.

ORDER

This Criminal Original Petition has been filed to set aside the adjudication order dated 10.09.2025 in Crl.A.407 of 2025 passed by the II Additional City Civil Court, Chennai and extend the time for depositing 20% of the cheque amount as directed while suspending the sentence in

the conditional order of the Principal Judge was not complied with and also directed the trial Court to execute the Warrant and to report by 08.10.2025.

Hence, challenging the same, the present petition is filed.

3. The learned counsel for the petitioner would submit that the petitioner has got a good case on merits. The petitioner, without prejudice to his rights and contentions, is ready to deposit 10% of the cheque amount and would seek for modification and extension of time.

4. Considering the submissions of the learned counsel for the petitioner, the adjudication order dated 10.09.2025 passed in Crl.A.407 of 2025 by the II Additional City Civil Court, Chennai, is set aside.

5. The condition imposed by the I Additional Sessions Judge, Chennai in Crl.M.P.No.1 of 2025 in Crl.A.No.407 of 2025 dated 26.03.2025, in respect of deposit of 20% of the compensation amount before the trial Court, is modified to the effect that the petitioner shall deposit 10% of the compensation amount before the trial Court to the credit of STC No.2733 of 2023, within a period of four weeks from today (07.11.2025).
