ORDER

The petitioner, who was arrested and remanded to judicial custody
on 22.10.2025, for the offence punishable under Section 7 of the Prevention
of Corruption (Amendment) Act, 2018, in Crime No.03/AC/2025/CC-IV,
registered on the file of the respondent, seeks bail.

2. The case of the prosecution is that the petitioner while working as a Village Administrative Officer had collected a sum of Rs.12,000/- from the defacto complainant for transfer of patta in the defacto complainant's name, accordingly complaint was lodged, trap was laid and the petitioner was caught red handed with the bribe money of Rs.12,000/-. Hence, the complaint.

3. The learned counsel appearing for the petitioner submitted that the petitioner is arrested and in custody since 22.10.2025 and the petitioner has been suspended from service. Hence, he prays to grant bail to the petitioner.

4. Learned Government Advocate (Crl.Side) appearing for the respondent police opposed the grant of bail to the petitioner, reiterating the prosecution case and submitted that A2, who was working as Office Assistant with A1 is still absconding. He further submitted that the investigation in this case has not yet been completed.

5. Heard both sides and perused the materials available on record.

6. Considering the nature of the allegations, the fact that the petitioner has already been suspended from service, she being the lady and taking into account the period of incarceration, this Court is inclined to grant bail to the petitioner with certain conditions:

7. Accordingly, the petitioner is ordered to be released on bail on his executing a bond for a sum of **Rs.20,000/- (Rupees Twenty Thousand only)** with **two sureties**, each for a like sum to the satisfaction of the learned **Principal District and Sessions Judge, Chengalpattu**, and on further conditions that:

[a] the sureties shall affix their photographs and Left Thumb Impression in the Application for Surety ship [Judicial Form No.46 annexed to 'The Criminal Rules of Practice, 2019']. The learned Magistrate shall obtain a copy of any one of the identity proofs to ensure their identity;

[b] the petitioner shall report before the respondent police daily at 10.30 a.m., for a period of three weeks, and thereafter as and when required for interrogation;

[c] the petitioner shall make himself available for interrogation by a Police Officer as and when required;

[d] the petitioner shall not directly or indirectly cause any threat to the de facto complainant and witnesses;

[e] the petitioner to give an undertaking that if required for being identified by witnesses during investigation or for police custody beyond the first fifteen days, he shall comply to the directions as may be given by the Court in this regard;

[f] On breach of any of the aforementioned conditions, the learned Magistrate/Trial Court is entitled to pass appropriate orders against the petitioner in accordance with law as if the aforementioned conditions have been imposed and the petitioner released on bail by the learned Magistrate/Trial Court himself as laid down by the Hon'ble Supreme Court in **P.K.Shaji vs. State of Kerala [(2005)13 SCC 283]**;

[g] If the accused thereafter absconds, a fresh FIR can be registered under Section 269 of B.N.S.
