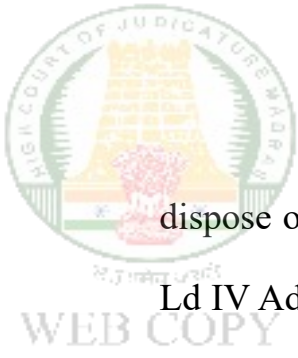

ORDER

This Civil Revision Petition is filed seeking direction to the Trial Court to
dispose of the I.A.No.9 of 2025 in O.S.No.1036 of 2023, within a time frame, as
fixed by this court.

2. The respondent herein filed the above said suit against the petitioner
herein/1st defendant and another for recovery of money, based on the
promissory note. In the said suit, the property of the petitioner was attached and
hence, to raise the attachment, the petitioner herein, filed the instant application.

3. It is seen from the affidavit filed in support of the petition to raise
