Side) appearing for the first respondent police would submit that based on the complaint given by one Naveen Kumar, enquiry was conducted in C.S.R.No.297 of 2025, by the first respondent police and during the course of investigation, it came to light that an amount of Rs.4,100/- was transferred to the account of the petitioner in State Bank of India, Villupuram Branch. He would further submit that a communication has been sent by the first respondent to Bank concerned on 08.11.2025, directing to mark lien of Rs.4,100/- in the account of the petitioner. Other than that, the first respondent has informed that there is no other case
