Therefore, this Court finds no infirmity or illegality in the communication dated 11.09.2024. This writ petition is devoid of merits and therefore, the writ petition stands dismissed. However, the petitioner has submitted all those documents and it is pending on the file of the fourth respondent.

3. In view of the above, the fourth respondent is directed to forward the same to the concerned authorities for consideration within a period of two weeks from today. No costs. W.M.P.No.48205 of 2025 is closed.
