ORDER

This criminal original petition has been filed seeking to direct the learned Judicial Magistrate VII, Coimbatore to dispose of the case in C.C.No.860 of 2024 arising out of Crime No.15 of 2022 registered for the offences under Sections 406, 420 & 468 of IPC on the file of the 1st respondent Police, within a period of three months.

2. When the matter was taken up for hearing, the learned Government Advocate (Crl. Side) appearing for the 1st respondent submitted that it is a case of financial fraud pertaining to job racketeering and that there are 44 witnesses in this case and the case is now posted on 10.12.2025 for
