3.It is made clear that, this Court vide order dated 23.09.2025 in W.P.No.36000 of 2025, directed the Official respondents to dispose of the representation dated 15.03.2025 made by the petitioner therein, on merits and in accordance with law, and if there is any obstruction for measuring the property, the Official respondents are directed to complete the survey with the aid of the Police and this Court had never directed the respondents to evict the persons who are all in possession of the 1st respondent's property. In the event, if any third parties are in possession of the 1st respondent's property, the 1st respondent cannot evict them through the Official respondents herein and the Police Personnel, who were deputed for the process of measuring the property and the right course available for the 1st respondent to evict them by way of obtaining orders from Court.

4.In view of the above, there is no merits in the present petition. Hence, the present petition stands dismissed. The Official respondents are directed to
