PRAYER: Writ Petition filed under Article 226 of the Constitution of India, to issue a Writ of Mandamus directing the Respondents to pay the petitioner a sum of Rs.18,500/- towards the amount payable under the Post Retirement Benefit Fund scheme; to pay the petitioner a sum of Rs.4,500/- towards IRT contributions; together with interest at the rate of 12 % per annum for the belated payment of Rs.11,19,387/- towards PF and for the belated payment of Rs.6,19,539/- towards Earned Leave / Medical Leave Salary and to pay the Petitioner interest at the rate of 12 % per annum for the belated payment of Rs.13,67,418/- towards gratuity, within a special time frame, as may be fixed by this Court.

ORDER

This writ petition has been filed for direction to the Respondents to pay the petitioner a sum of Rs.18,500/- towards the amount payable under the Post Retirement Benefit Fund scheme; to pay the petitioner a sum of Rs.4,500/- towards IRT contributions; together with interest at the rate of 12 % per annum for the belated payment of Rs.11,19,387/- towards PF and for the belated payment of Rs.6,19,539/- towards Earned Leave / Medical Leave Salary and to pay the Petitioner interest at the rate of 12 % per annum for the belated payment of Rs.13,67,418/- towards gratuity, within a special time frame, as may be fixed by this Court.

2. The case of the petitioner is that he is a retired employee of the Respondents/Corporation. The grievance of the petitioner is that the respondents have to pay the petitioner a sum of Rs.18,500/- towards the amount payable under the Post Retirement Benefit Fund scheme; to pay the petitioner a sum of Rs.4,500/- towards IRT contributions; together

with interest at the rate of 12 % per annum for the belated payment of

Rs.11,19,387/- towards PF and for the belated payment of Rs.6,19,539/-

towards Earned Leave / Medical Leave Salary and to pay the Petitioner

interest at the rate of 12 % per annum for the belated payment of

Rs.13,67,418/- towards gratuity. Hence, the petitioner made a

representation to the respondents on 25.01.2025. However, no action has

been taken by the respondents till date. Hence this petition.

3.The learned counsel for the petitioner submitted that it would be suffice if this Court issues a direction to the respondents to consider the petitioner's representation and pass orders.

4. The learned Standing Counsel appearing for the first respondent submitted that the representation of the petitioner will be considered and will pay the eligible amount with 6% interest per annum as per the earlier orders of this Court.

5. Considering the facts of the case, this Court directs the respondents to consider the representation of the petitioner and pass

orders on the claim made by the petitioner within a period of twelve weeks from the date of receipt of a copy of this Order. With regard to interest for the belated payment it will be applicable percentage of interest per annum from the date on which the amount became due and payable till the date of disbursement. It is made clear that if the amount is not paid within the time frame fixed by this Court, the same will carry interest at the rate of 12% per annum from the date on which the amount became due and payable till the date of disbursement.

6. With the above directions, this Writ Petition stands disposed of.
