PRAYER: Writ Petition (Criminal) is filed under Article 226 of the Constitution of India, to issue a Writ of Mandamus or direction in the nature of writ, to direct the respondents 1 to 3 to initiate a disciplinary action against respondents 4 to 11 caused for filing a false case registered against the petitioner and consistently life threat to the petitioner and his family by

Therefore, on the basis of the petitioner's representation dated 22.07.2025 and provide appropriate compensation to the petitioner Rs.10,00,000/- lakhs each of them for mental anguish, financial loss to the petitioner legal profession and tarnishing of the petitioner's reputation.
