A representation dated 07.11.2025 has been made by petitioner requesting authorities not to construct Panchayat office on a land, which, according to petitioner, is occasionally used for religious congregation.

2. There is nothing in the petition to show that the land belongs to temple authorities. The land apparently is a Government land. Therefore, no direction can be issued by this Court. However, taking

into consideration the sentiments expressed, it is open to petitioner to pursue his representation before the authorities.

3. Petition is dismissed. There shall be no order as to costs.

Consequently, the interim application is also dismissed.
