2.Heard Mr.J.Selvarajan, learned counsel appearing on behalf of the petitioner and Mr.C.Jayaprakash, learned Government Advocate appearing on behalf of the respondents 1 to 4.

3.In the considered view of this Court, the online rejection order of the 4th respondent is in violation of principles of natural justice, since the 4th respondent has not even mentioned any reasons as to why the application was rejected. That by itself is a ground for this Court to interfere with the online rejection order.

4.In view of the above, the online rejection order of the 4th respondent dated 28.02.2025, is hereby quashed and there shall be a direction to the 3rd and 4th respondents to deal with the application submitted by the petitioner and if the 3rd and 4th respondents wants to get any clarification from the petitioner, the same shall be done and final decision shall be taken, within a period of four



weeks from the date of receipt of copy of this order.
