ORDER

This writ petition has been filed challenging the order dated 11.10.2023 thereby placing the petitioner as non teaching staff from the teaching staff.

2. The petitioner was qualified to be appointed as Teacher. Thereafter, he was appointed in the post of Graduate Teacher in Vivekananda Higher Secondary School. Thereafter, he was appointed as Teacher in the second respondent school on 01.06.2007. While being so, by an order dated 11.10.2023, he was placed as non teaching staff. From the order dated 11.10.2023, the petitioner is working as non teaching staff in the second respondent school. After period of two years, the petitioner challenged the said order, that too having been worked as non teaching staff in the second respondent school. That apart, on perusal of the order passed by the second respondent dated 11.10.2023, it is revealed that the teaching method of the petitioner was not student friendly. Most of the time, the petitioner used to leave the place without any explanation. Therefore, the students were unable to understand Science subject. As such, this Court finds no infirmity or illegality in the impugned order.
