ORDER

4.In view of the same, this Court directs the second respondent to pass final orders, after hearing the objections of the sixth respondent, on merits and in accordance with law on the petitioner's application dated 13.09.2023 seeking for cancellation of patta for the property morefully described in the prayer to this writ petition, which is now standing in the name of sixth respondent within a period of 8 weeks from the date of receipt of a copy



of this order. With the above observation, this writ petition stands disposed of.
