These disputed questions of fact cannot be gone into in writ proceedings. The petitioners may avail ordinary civil remedy, as may be available to them.

3. With the aforesaid liberty, the writ petition is disposed of. There shall be no order as to costs. W.M.P.No.54588 of 2025 filed to permit the petitioners to file a single writ petition is ordered, subject to payment of separate court-fee within two weeks. W.M.P.No.54589 of 2025 is closed.
