ORDER

This writ petition has been filed seeking for a limited relief. The petitioner seeks for early disposal of her application pending before the third respondent seeking for cancellation of patta issued in favour of the respondents 4 to 8 for the property morefully described in the affidavit filed in support of this writ petition.

(a) The second respondent is directed to pass final orders on the petitioner's representation dated 05.05.2025 seeking for cancellation of patta issued in favour of the private respondents, after hearing objections from the private respondents and also by adhering to the principles of natural justice.

(b) The above said exercise shall be completed by the second respondent within a period of 12 weeks from the date of receipt of a copy of this order.
