2. The petitioner had submitted her representations dated 24.09.2025 & 10.10.2025 for the aforesaid purpose. Since the same have not been considered till date, the petitioner has filed this writ petition.

3. Mr.R.P.Murugan Raja, learned Government Advocate accepts notice on behalf of the respondents.

4. No prejudice will be caused to the respondents 4 and 5 if the said authorities are directed to survey and demarcate the boundaries of the petitioner's property morefully described in the prayer to this writ petition, after hearing the objections if any from the neighbouring land owners as well as any other party as they deem fit. Accordingly, this writ petition is disposed of in the following manner:-

(a) Before surveying the lands in question, the fourth respondent is directed to issue notice to the neighbouring land owners, and also to any other party, if they deem fit to put on notice.

(b) After receiving objections if any and after considering the same, the fourth respondent shall conduct survey and demarcate the boundaries of the property morefully descried in the prayer to this writ petition, on merits and in accordance with law, within a period of 12



weeks from the date of receipt of a copy of this order.
