## **ORDER**

This criminal original petition has been filed seeking to direct the 1<sup>st</sup> respondent not to harass the petitioner under the guise of enquiry.

2. The case of the petitioner is that under the pretext of conducting an enquiry in connection with the false complaint given by the 2<sup>nd</sup> respondent, the 1<sup>st</sup> respondent is unnecessarily harassing her.

3. Learned Government Advocate (Criminal Side) appearing for the 1<sup>st</sup> respondent, on instructions, submitted that based on the complaint given by the 2<sup>nd</sup> respondent/de-facto complainant, an FIR came to be registered in Crime No.204 of 2024 on the file of the 1<sup>st</sup> respondent and that the petitioner was called only for enquiry and she has not been harassed by the respondent police.

4. In such circumstances, it is for the Investigating Agency to issue appropriate notice to the petitioner under Section 35(3) of BNSS for enquiry and on receipt of such notice, the petitioner shall appear for enquiry and co-

operate in the investigation. It is made clear that the petitioner shall not be harassed during the course of enquiry.

5. Accordingly, this criminal original petition stands disposed of.
